### **Stakeholder engagement in sustainable finance: Indigenous Peoples Rights and the Free, Prior and Informed Consent**

Tuesday 5<sup>th</sup> December, 16.00 – 17.30 CET

Since the adoption of the UN Guiding Principles on Business and Human Rights (UNGPs) in 2011, financial institutions have increasingly recognized and owned their ‘responsibility to respect human rights’, developing human rights due diligence processes or strengthening internal risk management frameworks to address social risks. At the same time, more and more financial institutions commit to the global vision of sustainable development offered by the Sustainable Development Goals, by tackling social issues such as climate justice, gender inclusion and empowerment of vulnerable groups.

Despite this progress, indigenous peoples’ rights – which lie at the crossroads between development needs and international human rights norms – remain a burning topic on the finance and human rights agenda. Ten years on since the adoption of United Nations Declaration on the Rights of Indigenous Peoples, obtaining the free, prior and informed consent of affected communities and groups in the development of business projects is a particularly challenging endeavour. This challenge has a direct impact on the right-holders but also on financial institutions involved in the financing of activities that affect indigenous peoples and communities.

The webinar, organized jointly by Agence française de développement, the Inter-American Development Bank and UNEP Finance Initiative, will take a glimpse into the current landscape of standards and practices related to indigenous peoples’ rights and stakeholder engagement, with a focus on the free, prior and informed consent principle. It will also consider barriers to the principle implementation and solutions to address them. It will be set up as a platform of knowledge exchange between industry representatives and human rights experts working with indigenous groups and on stakeholder engagement in business.
